Goal 1

We will improve proficiency in ELA school-wide. Teachers will implement research-based instructional strategies, differentiation and interventions.

Objective(s):

Our goal is to raise overall proficiency and close the achievement gap in ELA (whole school & sub populations). Proficiency will increase to 71%. MGP will go from 44 to 48%. FRL AGP will increase from 49.5 to 62%. IEP AGP will increase from 48 to 50%. ELL AGP will increase from 23.5 to 30%.

Goal 2

We will improve proficiency in Math school wide. Teachers will implement research-based instructional strategies, differentiation and interventions.

Objective(s):

Our goal is to raise overall proficiency and close the achievement gap in math (whole school & all sub populations). Proficiency will increase to 74%. MGP wil go from 25 to 50%. FRL AGP will increase from 18.3 to 42%. IEP AGP will increase from 33.3 to 40%. ELL AGP will increase from 0 to 19%.

School Communication Efforts

Parents are our partners in education at Fremont Elementary School. Communication with our families is paramount. We use weekly Peechees, our monthly newsletter, quarterly grade-level goals notes, classroom newsletters and notes, CCSD website, special events fliers, and our phone messenger system to keep parents informed about student progress and school events. All message and notes are sent in both English and Spanish. Report cards and SFA reading progress reports are sent home quarterly. We hold parent, teacher, and student conferences at the end of the first and third quarters. Awards ceremonies for students and parents are held quarterly. Quarterly school data is shown in a power point presentation at this time. Parent information/training nights are held throughout the year to inform families about the school accountability process, student conferences, and NACS for ELA, Math, and Science to empower them to assist their students with academics.
